COUNSELLING SYSTEM

AVR counselling is centralized in Austria. There are no differences with regards to rules and regulations between the 9 federal states.



The reintegration assistance is not limited to a few countries of return with existing national reintegration projects anymore but it is rather available in almost all countries of return by using the many contacts of the reintegration partners which are connected and accessible through the ERSO network

FINANCIAL SUPPORT

Returnees to all countries of return receive between $50 \in$ minimum and 370 E maximum according to regulations, which are decided by the BFA (Federal Office for Immigration and Asylum). The reintegration assistance of ERIN or IRMA Plus can amount to 3000 € per client.

NEW PROJECT

In March 2016 the graded voluntary return project was launched for returnees from Nigeria, Morocco and Afghanistan. The return support is graded according to the length of stay in Austria: • Return within the first three months of arrival -> $500 \in$ • Return between 3rd and 6th month -> $250 \in$ • Return after 6 months -> only 50 €

COUNTRY SPECIFIC DETAILS

• Funded by AMIF and Ministry of the Interior Projects based on specifications of Ministry

• Special procedure for unaccompanied minors: The legal guardian is included or informed about every step in the return preparation • The asylum authorities provide additional 1000 € for travel escorts (usually the AVR counsellor), when a mortally ill returnee wants to stay for the remaining life time in the country of origin; a travel escort is also financed for severely mentally ill returnees • Exception: in case the return does not seem like a unanimous decision of the whole family single family members aged above 14 get an individual counselling session (in order to provide a space to voice possible fears of professional or educational disadvantages, forced marriage, prostitution, etc.)

• Returnees from the Federal State Vorarlberg may receive additional 1000 E reintegration support
