### COUNSELLING SYSTEM

- 2 STAGE MODEL
- Stage I: Return Counselling offered by numerous providers all over the country
- First contact and counselling, information about AVR, examination of eligibility for reintegration support
- Organization of flight ticket and travel money through IOM
- Stage 2: Reintegration Counselling offered by 4 CIB counsellors and 5 10M counsellors in all of Belgium
- Development of reintegration plan
- Establishing contact between returnee and reintegration partner through telephone or skype
- Follow-up assistance and support after return
- Regular monitoring

#### REINTEGRATION PROJECTS

- National Program (AMIF&FEDASIL): reintegration assistance to all countries of return possible
- ERIN: Russia, Morocco, Afghanistan, Iran, Nigeria, Pakistan

#### HANDLING OF VULNERABLE CASES

• The vulnerable client receives more counselling as well as more preparation time with the reintegration partner

COUNTRY SPECIFIC DETAILS

- The reintegration counsellors may apply for 500 € add-ons reintegration assistance for returnees with a vulnerable profile directly with FEDASIL regardless of the administrative status
- · Assisted Medical Assistance After Return (AMAAR): financial support up to 5000 £ medical care (chronic diseases, surgeries) for the first 6 months after return
- Unaccompanied minors (UAM) receive 2200 € regardless of their administrative status; their parents may receive 700 € additionally for the extra expenses, the returnee may cause

#### SPECIAL FEATURES REGARDING REPATRIATION

- Successful outreach to irregular migrants through NGOs with regards to voluntary return
- European Reintegration Support Organizations (ERSO)
- Future Orientation Project: trainers counsel rejected asylum seekers or people with precarious residence status with the aim to establish a positive but realistic view on the future in Belgium or the country of return (Aspects: Recognition, Insight, Reflection, Clients taking control of their lives)
- City projects: incorporation of voluntary return service in civil services in order to raise more awareness about the option of voluntary return

#### FINANCIAL SUPPORT

Group A (asylum-seekers) is entitled to 250 € return money, 700 € reintegration assistance per adult and additional 1500 € per case for assistance in setting up a micro business or finding a job; children receive 350 £ in kind assistance. Group B (people who requested asylum once or who registered for family reunification but were rejected) receives the return and reintegration assistance but not the 1500 £. Group C (Irregular migrants) only receives 250 € return money. Persons without visa requirements to enter Belgium can obtain a flight ticket (no cash assistance) to return. Vulnerable clients may receive extra funding.
