ASSISTED VOLUNTARY REINTEGRATION (AVRR) COUNSELLING

AVRR counselling provides assistance to (former) asylum seekers in Europe who decide to return voluntarily to their countries of origin.

PRE-DEPARTURE COUNSELLING

- » Open and unbiased counselling (providing country-specific information, discussing perspectives in host country and country of return, developing future prospects)
- » Funding of travel expenses (flight ticket and initial financial assistance)
- » Referral to reintegration partner

REINTEGRATION ASSISTANCE

- » Psycho-social follow-up care through local reintegration partner
- » Financial assistance for small-income generating activity
- » Medical and educational interim aid
- » Professional training



OBJECTIVES

- Caritas Augsburg leads the cooperation project Transnational Exchange IV with the following objectives:
- » Connect return and reintegration counsellors on a European level
 - » Provide exchange platforms such as workshops and conferences for return and reintegration counsellors, reintegration partners and policy makers
 - » Offer firsthand information about the countries of return through reintegration partners
 - » Improve counselling quality through region-specific training on relevant topics
 - » Collect information and counselling tools and make them available to European AVRR counsellors

STRUCTURE

The following activities will be carried out from July 2018 to June 2020:

- » Three region-specific workshops for European AVRR counsellors
- » One conference for EU-wide exchange for all relevant actors including counsellors, coordinators and policy makers
- » One field visit for European counsellors to a European country exploring its AVRR counselling services
- » One field visit for European counsellors to a country of return exploring the reintegration process
